- 1 For the purposes of the Data Protection Act 2018, the information you have provided will be held and processed by Mercer as administrator of the MRC Pension Scheme.
- 2 Your nomination will be treated in the strictest confidence at all times.
- 3 In the event of a claim for a dependant's pension, the Trustee Directors of the MRC Pension Scheme will need to be satisfied that the declarations made are valid and your relationship continued to meet the qualifying conditions for payment of a dependant's pension.
- 4 In order to be considered as a long-term relationship, it must have been in existence for two or more years at the time a death claim is made.
- 5 Where the partner is more than ten years younger than the scheme member, the dependant's pension will be reduced by such amount as the Trustee Directors decide is appropriate, based on the advice of the government actuary.
- 6 A dependant's pension once in payment shall cease in the event that the surviving partner enters into marriage, a registered civil partnership, or co-habits with another person as a partner.
- 7 Should your circumstances change, you should contact Mercer in writing at the earliest opportunity.
